### **OUR PAYMENT POLICY**

To lose someone you love is a devastating human experience. It is frequently traumatic and can seriously impact judgment. We believe in importance of the recognition and meaningful celebration of a life that has been lived and will assist in arranging an appropriate service to meet your individual needs.

It is also important to be realistic in respect to funeral expenditures. We do not want a family to spend more than they are able nor less than they would like. What is important is that the arrangements be in keeping with a family's wishes and budget. Provisions for payment are due at the time of the arrangements. To avoid any possibility of misunderstanding or embarrassment and for your convenience we accept the following payment methods:

### **ITEMIZED SELECTIONS**

*The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.*

**BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF .....\$750.00**

Our services include, but are not limited to, personnel on duty 24 hours a day to respond to your initial request for service, care and sheltering of the remains, preparation and filing of the death certificate and permits as necessary, consultation with the family (Monday - Friday), and coordination of service plans with the cemetery, crematory and others responsible for the final disposition of the deceased. This fee also includes a proportionate share of our basic overhead costs such as facility maintenance, administration, insurance, equipment and inventory costs and governmental compliance. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

**EMBALMING .(Standard Case)..... \$725.00**

*Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.*

**IMMEDIATE BURIAL**...\$1750.00 to \$ 8100.00 *Our charge for an immediate burial (without viewing, rites or ceremony at the funeral home, gravesite or elsewhere) includes basic services of the funeral director and staff, a proportionate share of overhead costs, local removal of remains from place of death, up to 3 days refrigeration, dressing and casketing of remains. and transportation to local cemetery.*

**DIRECT CREMATION**...\$725.00 to \$ 7225.00 *Our charges include basic services of the funeral director and staff, a proportionate share of overhead costs, removal of remains from local place of death, two days (48 hours) of refrigeration, obtaining necessary authorizations and consents. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering).The container we provide is unfinished fiberboard. We reserve the right to refuse remains weighing over 299 lbs.*

## FORWARDING REMAINS TO ANOTHER FUNERAL HOME

Our services include basic services of the funeral director and staff, removal of remains from local place of death, transportation to airport, and standard embalming. Autopsy/Tissue Donor Repair, Viewing, funeral ceremony, shipping container and airline fees, etc. are not included.

## RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME.....\$ 1175.00

Our services include basic services of the funeral director and staff, transportation from local airport and transportation to the local cemetery or crematory using a funeral vehicle in lieu of hearse. Viewing, funeral ceremony, dressing, casketing and cosmetics, additional transportation or cemetery fees, etc. are not included.

## DISINTERMENT SERVICE: \$1000.00

Our charges include limited services of the funeral director and staff, securing necessary authorizations and permits, and funeral director to supervise disinterment at local cemetery. Cemetery fees, permit fee, transportation, and express mail service charges are not included.

## MEDICAL SCHOOL DONATION SERVICE FEE: \$1300.00

Our charge includes limited services of funeral director and staff, transfer of deceased from place of death to funeral home, and two-days refrigeration. Additional transportation and preparation (embalming) is not included.

## NATURAL ORGANIC REDUCTION/ TERRAMATION: \$5500.00

Our charge includes limited services of funeral director and staff, and transfer of deceased from place of death to funeral home. refrigeration care, combination air tray, transportation to the local airport, disposition of remains into compost through the process of Terramation (Natural Organic Reduction), packaging and pickup of soil at facility, shipping of a small portion of Terramated remains to any US or Canadian address, delivery of excess soil to Return Home Woodland in Kent, WA,), WA state taxes and county fees, online tracking of loved one through the process, online memorial website. Additional transportation, airline cargo fees, death certificates, viewing are not included.
